

### Judge's Corner Continued.....

As you know, we have a magistrate assigned to cover our first appearance center. Due to scheduling changes, Magistrate Clay Hurst will be providing that coverage on Monday through Wednesday of every week. For the rest of the week, Magistrate Hurst will be assigned to provide coverage in Arapahoe County. During those 2 days, the first appearance center will be covered by one of our Douglas County Judges.

Finally, the annual Judicial Conference this year will be on Monday, September 21<sup>st</sup> and 22<sup>nd</sup>. Some judicial officers will also be attending sessions on Wednesday, September 23<sup>rd</sup>. Please be aware that most judicial officers will not be present in Douglas County on Monday, September 21 or September 22, 2015. A senior judge will be present in the courthouse to provide coverage for emergency and in custody matters.
