NOTES FROM VIRGINIA ROBBINS-

Our Judiciary- Profesionalism Matters



On October 29, 2015, the Douglas Elbert Bar Association, Aurora Bar Association, and the 18th Judicial District Court Judges co-hosted a Professionalism Matters dinner addressing diversity from the prospective of the bench. District Court Judge Chris Cross moderated a group of panelists that included Colorado Supreme Court Justice Marquez, Colorado District Court Chief Judge Samour, Colorado County Court Judge Rowles-Stokes, Governor Hickenlooper's Chief Legal Counsel, Ms. Cooper Melmed, and a current member of the 18th Judicial District Nominating Commission Ms. Fay Matsukage.

While the panelist fielded questions from the audience regarding the Judges' perspective of diversity on the bench, the panelists offered their individual perspective on why there is a need for diversity on the bench and how diversity leads to judicial fairness

Justice Marquez, Judge Samour and Judge Rowles-Stokes each discussed their views on diversity and all agreed that diversity is needed in order to represent society's diverse population. The Judges discussed the lack of diversity on the bench is a result of the low percentage of minorities applying for positions on the bench. Without a higher number of minority applicants applying for judge positions, the bench will not achieve the diversity society needs. Ms. Melmed and Ms. Matsukage discussed the process of screening applicants for judicial positions and stated the number of minority applicants is extremely low. Although the committee does look at the applicant's minority status, the committee fills judicial positions based on the most qualified candidate.

The panelists all agreed that an increase of diversity on the bench must begin with an increase of minority applicants. Discussion among the panelists indicated the need for an increase in mentors to encourage minorities to apply for judicial positions and the need for an increase of minorities to seek law clerk positions, government positions within the district attorney's office, public defender's office and the attorney general's office.

The evening offered a great perspective from the bench regarding diversity, along with why and how to achieve diversity and judicial fairness in the community.
